Following the war in Ukraine and the challenges facing Europe at its borders, French local and regional authorities have a major role to play in supporting the territories of the Eastern neighbourhood countries on the road to greater integration and partnership with the European Union.

In particular, in the context of strong tensions facing the Moldovan authorities, the support and initiatives of French local and regional elected officials are essential for their Moldovan counterparts.

With the support of the Delegation for the External Action of Local and Regional Authorities (DAECT) of the French Ministry of Europe and Foreign Affairs, the French Embassy in Moldova and the PLATFORMA network supported by our European organisation, the CEMR, Our Association has been involved for several years in cooperation actions with the local and regional authorities of the Republic of Moldova, whose status as a candidate to the European Union, just like Ukraine, was approved by the European Council on 23 June 2022, which thus confirmed the European vocation of these countries.

This conference, organised in direct collaboration with the French Embassy in Moldova, will provide an opportunity for exchanges between French and Moldovan elected representatives and national and local officials.

The first day will be devoted to thematic round tables, dedicated to the issues of territorial organisation, public finance or management of public services, while the second day will be more focused on the political dialogue with the countries of the Eastern Partnership and the Balkans in the perspective of accession, and the role that cooperation between local authorities can play.

Created in 2008 at CEMR's initiative, the PLATFORMA network brings together European local and regional authorities and their associations active in development cooperation. Since 2015, it has benefited from financial support from the European Commission for its numerous activities throughout Europe.

Within this framework and with the support of the PLATFORMA network, AFCCRE proposes numerous actions on several priority themes: gender equality, awareness-raising on development and decentralised cooperation, cooperation on climate and energy, dialogue with the EU's eastern neighbourhood, in addition to its training and advocacy activity in favour of the recognition of the external action of local and regional authorities
