Aims of the seminar

In EU development policy, the idea that the EU should seek to engage strategically with local governments in pursuit of development goals is familiar (at least since the Commission's 2013 Communication on empowering local authorities). Likewise, within the EU, it is often noted (after the Committee of the Regions' 2006 opinion on subsidiarity) that 'the local and regional level is responsible for implementing more than 70 % of EU legislative acts'.

One aim of this seminar is to ask what the EU's vision should be for engaging with the local level in the Eastern Trio as they move (with Georgia's candidate status and the opening of accession negotiations in Moldova and Ukraine) from 'Neighbourhood' to 'Enlargement'. Sometimes local government is seen as just another stakeholder or as a complement to central government. But if local authorities are strategic partners in the development sphere, should they not be all the more so once they take on responsibility for implementing significant parts of the EU acquis?

Another aim is to share experiences among candidate countries on how the local level can become better involved in EU integration. Accession has a profound impact on local authorities as service providers, employers, regulators, procurers of goods and services, investors, and upholders of standards. In the past, mayors have sometimes 'woken up too late' to commitments made on their behalf, and best use has not always been made of EU funding intended to help smooth preparations.

More recently, some candidate countries have sought to include local representatives, for example in consultation mechanisms, in working groups underlying the accession negotiations or in capacity-building. Local government associations (LGAs) have a special role in promoting dialogue with central government and in preparing their members, for whom the EU may not (yet) figure highly among day-to-day priorities. The seminar will showcase LGAs' efforts, for example in assessing the impact of EU membership at the local level, or in creating networks of EU focal points in municipalities.

A third main aim is to **explore the scope for local involvement in EU-financed projects**, both under current instruments, and – as discussions on the post-2027 package begin – under the successors to the Neigbourhood, Development and International Cooperation Instrument (NDICI) and the Instrument for Pre-Accession Assistance.

The recent (March 2024) evaluation of the EU's external financing instruments found that support to local authorities 'has been de facto deprioritised' after the discontinuation of a thematic budget line for local authorities. Although the NDICI regulation called for at least € 500m within geographical programmes to support local authorities, they do not appear in most of these programmes. What could be done to remedy this in the final years of the 2021–27 framework?

The new Growth Plans for the Western Balkans and Moldova and the Ukraine Facility are seen by many as reflecting a shift towards staged enlargement, with increased financial assistance conditional on progress with reforms. But if more funding goes to national budget support and to blended grants and loans through the development banks, how will local access be assured? Or to look at it another way, how will the role of local authorities in the reform agenda be recognised?







The seminar will seek to answer these questions and more and, following the day's discussions, to compile concrete recommendations addressed to stakeholders and decision-makers at the EU, national and of course local levels.
